

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Repealing Resolution No. 21-424 "Approving FY 2021 Radio Use Agreement Between the Tohono O'odham Nation and Drexel Heights Fire District" and Approving FY 2022 Radio Use Agreement Between the Tohono O'odham Nation and Drexel Heights Fire District)

RESOLUTION NO. 21-443

1 **WHEREAS,** the Constitution of the Tohono O'odham Nation vests the Legislative Council with
2 the power "to promote, protect, and provide for . . . general welfare of the Tohono
3 O'odham Nation and its members" and "[t]o consult, negotiate and conclude
4 agreements and contracts on behalf of the Tohono O'odham Nation with Federal,
5 State and local governments . . . on all matters within the authority of the Tohono
6 O'odham Council." (Constitution, Article VI, Section 1(c)(2) and Section 1(f)); and

7 **WHEREAS,** on November 15, 2021, the Tohono O'odham Nation Fire Department mistakenly
8 presented to the Legislative Council the already expired FY 2021 Radio Use
9 Agreement between the Tohono O'odham Nation and Drexel Heights Fire District,
10 which the Legislative Council approved by Resolution No. 21-424; and

11 **WHEREAS,** the Domestic Affairs Committee recommends repealing Resolution No. 21-424;
12 and

13 **WHEREAS,** the Tohono O'odham Nation Fire Department has submitted for review and
14 approval the FY 2022 Radio Use Agreement between the Tohono O'odham Nation
15 and Drexel Heights Fire District, which is incorporated by this reference, for the
16 period October 1, 2021 to September 30, 2022; and

17 **WHEREAS,** the FY 2022 Radio Use Agreement will allow Drexel Heights Fire District to act as a
18 billing administrator for the Nation's use of PCWIN radio equipment in San
19 Xavier District; and

20 **WHEREAS,** pursuant to 26 Tohono O'odham Code Chapter 1, Article 4 – Contracting and
21 Procurement Authority, intergovernmental agreements require approval by the
22 Legislative Council; and

23 **WHEREAS,** the Domestic Affairs Committee has reviewed the FY 2022 Radio Use Agreement
24 between the Tohono O'odham Nation and Drexel Heights Fire District and
25 recommends its approval.

26 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council:

- 27 1. **repeals Resolution No. 21-424; and**
- 28 2. **approves the FY 2022 Radio Use Agreement between the Tohono O'odham**
29 **Nation and Drexel Heights Fire District.**


