

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Department of Health and Human Services Division of
Behavioral Health Services First Things First Budget Amendment No. 1)**

RESOLUTION NO. 21-455

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2022 Department of Health and Human Services First Things First Budget**
8 **in the amount of \$152,208.00 was approved by Resolution No. 21-250 and;**

9 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**
10 **review and approval its FY 2022 Division of Behavioral Health Services First**
11 **Things First Budget Amendment No.1, which is incorporated by this reference**
12 **and which will adjust personnel and operational line items; and**

13 **WHEREAS, the FY 2022 Department of Health and Human Services Division of Behavioral**
14 **Health Services First Things First Budget Amendment No. 1 will not change the**
15 **original budget amount of \$152,208.00; and**

16 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
17 **reviewed the FY 2022 Department of Health and Human Services Division of**
18 **Behavioral Health Services First Things First Budget Amendment No. 1 and**
19 **recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2022 Department of Health and Human Services Division of Behavioral Health**
22 **Services First Things First Budget Amendment No.1 effective July 1, 2021 in the**
23 **amount of \$152,208.00 which shall be funded by the Arizona Early Childhood**
24 **Development and Health Board.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
26 **Nation chairperson or any designated official is authorized to administer and**
27 **expend the FY 2022 Department of Health and Human Services Division of**
28 **Behavioral Health Services First Things First Budget Amendment No. 1, provided**
29 **that any amendments or modifications shall be submitted for prior approval by**
30 **the Tohono O'odham Legislative Council.**


