

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Hewel Ni'ok KOHN Corporation for Public Broadcasting
Community Service Grant American Rescue Plan Act Stabilization Budget)**

RESOLUTION NO. 21-458

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Nation, on behalf of Hewel Ni'ok, a rural Corporation for Public Broadcasting**
8 **("CPB") Community Service Grantee, has received \$244,432.00 of the American**
9 **Rescue Plan Act ("ARPA") stability grant funds which are not subject to CPB's**
10 **statutory funding allocations but are restricted in the same manner that**
11 **Community Service Grant ("CSG") funds are restricted from using such funds for**
12 **entertainment or influencing legislation; and**

13 **WHEREAS, the American Rescue Plan Act stability grant funds have no expenditure period**
14 **and are to be used until fully expended to provide continued services; and**

15 **WHEREAS, Hewel Ni'ok has prepared and submitted for review and approval its FY 2022**
16 **Hewel Ni'ok KOHN CPB CSG ARPA Stabilization Budget obligating a portion of the**
17 **grant funding with the balance to be expended in fiscal years 2023 and 2024,**
18 **which is incorporated by this reference; and**

19 **WHEREAS, the Cultural Preservation and Budget and Finance Committees have reviewed the**
20 **FY 2022 Hewel Ni'ok KOHN CPB CSG ARPA Stabilization Budget and recommend**
21 **its approval.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
23 **FY 2022 Hewel Ni'ok KOHN Corporation for Public Broadcasting Community**
24 **Service Grant American Rescue Plan Act Stabilization Budget, effective October 1,**
25 **2021, obligating grant funds in the amount of \$104,307.57 that shall be funded by**
26 **CPB ARPA Stabilization funding received by the Nation and a calculated indirect**
27 **cost of \$11,515.98 for a total budget of \$115,823.55.**

28 **BE IT FURTHER RESOLVED that Hewel Ni'ok KOHN CPB CSG ARPA Stabilization Budget are**
29 **authorized until the grant fund are fully expended to provide continued services.**

30 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
31 **Nation chairperson or any designated official is authorized to administer and**
32 **expend the FY 2022 Hewel Ni'ok KOHN Corporation for Public Broadcasting**






