

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Barbara Atwood as a Pro Tempore Judge of the Tohono O'odham Judicial Court)**

RESOLUTION NO. 21-460

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the authority to appoint**
2 **judges to the Tohono O'odham Judicial Court (Constitution, Article VIII, Section**
3 **3); and**

4 **WHEREAS, the Legislative Council "may upon the recommendation of the chief judge**
5 **appoint pro tempore judges to the Judicial Court" (6 T.O.C. Chapter 1, Article 2,**
6 **Section 1201); and**

7 **WHEREAS, the term of a pro tempore judge "shall be set forth in the resolution of the**
8 **Legislative Council appointing the judge, but in no case shall the term be longer**
9 **than six years" (6 T.O.C. Chapter 1, Article 2, Section 1204); and**


10 **WHEREAS, the chief judge has submitted Barbara Atwood's resume, letter of interest, and a**
11 **letter of recommendation for her appointment as a pro tempore judge to the**
12 **Tohono O'odham Judicial Court; and**

13 **WHEREAS, the Judiciary Committee, having legislative oversight of matters pertaining to the**
14 **Tohono O'odham Judicial Court, reviewed Barbara Atwood's resume, letter of**
15 **interest, and the chief judge's letter of recommendation.**


16 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it appoints**
17 **Barbara Atwood to the Tohono O'odham Judicial Court as a pro tempore judge for**
18 **a six-year term commencing on the effective date of this resolution.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH**
20 **day of DECEMBER, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**
21 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by,**
22 **Article VIII, Section 3 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
23 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
25 **(48 Stat.984).**
