

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Baboquivari District Day Budget)**

RESOLUTION NO. 21-463

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the Tohono**
5 **O'odham Council. The management of these funds shall be only by a treasurer or**
6 **other authorized officer of the district council who has furnished a surety bond**
7 **satisfactory to the treasurer of the Tohono O'odham Nation, and all expenditures**
8 **of these funds shall be by checks signed by such treasurer or other authorized**
9 **officer and the chairman or vice chairman of the district council.**

11 **WHEREAS,** by Baboquivari District Council Resolution No. 2021-B-116, the Baboquivari
12 District has authorized the FY 2022 Baboquivari District Day Budget, which is
13 incorporated by this reference, in the amount of \$10,000.00; and

14 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2022 Baboquivari District
15 Day Budget and recommends approval.

16 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
17 **FY 2022 Baboquivari District Day Budget in the amount of \$10,000.00, which shall**
18 **be funded by August 2021 District Allocation.**


19 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2022
20 **Baboquivari District Day Budget shall be managed and expended in accordance**
21 **with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and**
22 **the Nation's laws, provided that any amendments or modifications shall be**
23 **authorized under District Council resolution and submitted for prior approval by**
24 **the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**
26 **day of DECEMBER, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**
27 **-0- AGAINST; [01] NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by,**
28 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
29 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
30 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**


