

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Department of Health and Human Services Division of Senior
Services Title VI Part C Caregivers American Rescue Plan Budget)**

RESOLUTION NO. 21-464

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services ("DHHS") has prepared and
8 submitted for review and approval its FY 2022 Division of Senior Services Title VI
9 Part C Caregivers American Rescue Plan Budget, which is incorporated by this
10 reference, in the amount of \$55,340.00 to be funded by the Nation's general fund
11 pending reimbursement from the grantor, the United States Department of
12 Health and Human Services Administration for Community Living; and

13 **WHEREAS,** the granting agency has awarded the project for a three-year period beginning
14 May 1, 2021 and ending September 30, 2024 and Department of Health and
15 Human Services Division of Senior Services has prepared multi-year budget to
16 fully expend the awarded grant funds; and

17 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
18 reviewed the FY 2022 DHHS Division of Senior Services Title VI Part C Caregivers
19 American Rescue Plan Budget and recommend its approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
21 FY 2022 Department of Health and Human Services Division of Senior Services
22 Title VI Part C Caregivers American Rescue Plan Budget effective May 1, 2021
23 through September 30, 2024 in the amount of \$55,340.00, which shall be funded
24 by the Nation's general fund pending reimbursement from the grantor, the
25 United States Department of Health and Human Services Administration for
26 Community Living and which waives indirect costs.

27 **BE IT FURTHER RESOLVED** by the Tohono O'odham Legislative Council that the Department of
28 Health and Human Services Division of Senior Services is authorized to utilize
29 funding for the three-year project period ending September 30, 2024 or until the
30 grant funds are fully expended to provide continued services in accordance with
31 the FY 2022 Department of Health and Human Services Division of Senior Services
32 Title VI Part C Caregivers American Rescue Plan Budget.



3 expend the FY 2022 Department of Health and Human Services Division of Senior
4 Services Title VI Part C Caregivers American Rescue Plan Budget, provided that
5 any amendments or modifications shall be submitted for prior approval by the
6 Tohono O'odham Legislative Council.

7 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH
8 day of DECEMBER, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;
9 -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by,
10 Article VI, Section 1 (d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by
11 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
12 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
13 18, 1934 (48 Stat.984).


