

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Judicial Branch New Probation Building Budget Amendment No. 1)**

RESOLUTION NO. 21-465

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation... and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2021 Judicial Branch New Probation Building Budget in the amount of**
8 **\$2,042,909.86 was approved by Resolution No. 20-379; and**

9 **WHEREAS, Resolution No. 20-379 provided that if funds remained at the end of FY 2021, the**
10 **Judicial Branch is authorized to continue expending funds from the FY 2021**
11 **Judicial Branch New Probation Budget into FY 2022 to complete the new**
12 **Probation Building project; and**

13 **WHEREAS, the Judicial Branch has prepared and submitted for review and approval its FY**
14 **2021 New Probation Building Budget Amendment No. 1, which is incorporated by**
15 **this reference and which will adjust operational and/or capital line items; and**

16 **WHEREAS, the FY 2021 Judicial Branch New Probation Building Budget Amendment No. 1 will**
17 **not change the budget amount of \$2,042,909.86; and**

18 **WHEREAS, the Judiciary and Budget and Finance Committees have reviewed the FY 2021**
19 **Judicial Branch New Probation Building Budget Amendment No. 1 and**
20 **recommend its approval.**


21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
22 **FY 2021 Judicial Branch New Probation Building Budget Amendment No. 1, which**
23 **will not change the budget amount of \$2,042,909.86.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Chief Judge or any**
25 **designated official is authorized to expend and administer the FY 2021 Judicial**
26 **Branch New Probation Building Budget, provided that any amendments or**
27 **modifications shall be submitted for prior approval by the Tohono O'odham**
28 **Legislative Council.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**
30 **day of DECEMBER, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**
31 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by,**
32 **Article VI, Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
33 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**


Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
