

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Department of Health and Human Services Healthy
O'odham Promotion Program Budget)**

RESOLUTION NO. 21-470

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services ("DHHS") has prepared and**
8 **submitted for review and approval its FY 2023 Healthy O'odham Promotion**
9 **Program Budget, which is incorporated by this reference, in the amount of**
10 **\$2,241,130.00 that shall be funded by the Indian Health Service Special Diabetes**
11 **Program for Indians; and**

12 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
13 **reviewed the FY 2023 DHHS Healthy O'odham Promotion Program Budget and**
14 **recommend its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
16 **FY 2023 DHHS Healthy O'odham Promotion Program Budget effective January 1,**
17 **2022 through December 31, 2022 in the amount of \$2,241,130.00, which shall be**
18 **funded by the Nation's general fund pending reimbursement from the grantor,**
19 **the Indian Health Service Special Diabetes Program for Indians.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
21 **Nation chairperson or any designated official is authorized to administer and**
22 **expend the FY 2023 DHHS Healthy O'odham Promotion Program Budget,**
23 **provided that any amendments or modifications shall be submitted for prior**
24 **approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
26 **day of DECEMBER, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**
27 **-0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by,**
28 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
29 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat.984).**




