

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 21-192, "Accepting U.S. Department of Health and Human Services
Centers for Disease Control and Prevention Supporting Tribal Public Health Capacity in
Coronavirus Preparedness and Response Grant and Approving FY 2021 Tohono O'odham
Nation Health Care CDC Capacity Grant Budget" to Extend the Budget Authority into FY 2022)**

RESOLUTION NO. 21-471

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2021 Tohono O'odham Nation Health Care CDC Capacity Grant Budget in**
8 **the amount of \$810,968.00 was approved by Resolution No. 21-192; and**

9 **WHEREAS, the budget authority under Resolution No. 21-192 expired on June 9, 2021; and**

10 **WHEREAS, the Tohono O'odham Nation Health Care is requesting the budget term be**
11 **extended into FY 2022 to expend available funds for the CDC Capacity Grant**
12 **Budget in the amount of \$810,968.00; and**

13 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
14 **reviewed the amending resolution and recommend its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council amends**
16 **Resolution No. 21-192 to extend the budget authority for the Tohono O'odham**
17 **Nation Health Care CDC Capacity Grant Budget in the amount of \$810,968.00**
18 **through June 9, 2022.**

19 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
20 **O'odham Nation chairperson or any designated official is authorized to**
21 **administer and expend these funds for the period of June 10, 2020 through June**
22 **9, 2022, provided that any amendments or modifications shall be submitted for**
23 **prior approval by the Tohono O'odham Legislative Council.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Accounting**
25 **Department is authorized to post the unexpended balances of the budget as of**
26 **June 9, 2021 as a carry forward into Fiscal Year 2022.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
28 **day of DECEMBER, 2021 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**
29 **-0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by,**
30 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat.984).**






