13		review and approval its FY 2022 Family Violence Prevention and Services Act
14		Budget, which is incorporated by this reference, in the amount of \$225,046.00 to
15		be funded by the Nation's general fund pending reimbursement from the U.S.
16		Department of Health and Human Services; and
17	WHEREAS,	the Health and Human Services and Budget and Finance Committees have
18		reviewed the FY 2022 Department of Health and Human Services Komchud Ki:
19		Family Violence Prevention and Services Act Budget and recommend its
20		approval.
21	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
22		FY 2022 Department of Health and Human Services Komchud Ki: Family Violence

25		reimbursement from the U.S. Department of Health and Human Services.
