The management of these funds shall be only by 6 a treasurer or other authorized officer of the district council who has 7 furnished a surety bond satisfactory to the treasurer of the Tohono 8 O'odham Nation, and all expenditures of these funds shall be by checks 9 signed by such treasurer or other authorized officer and the chairman or 10 vice chairman of the district council. 11 ; and 12 WHEREAS. by Sells District Council Resolution No. SD-123-21, the Sells District has 13 authorized the FY 2022 Sells District Economic Development Committee 14 Enterprise Renovations Budget, which is incorporated by this reference, in the 15 amount of \$484,934.00; and 16 WHEREAS, the Budget and Finance Committee has reviewed the FY 2022 Sells District 17 Economic Development Committee Enterprise Renovations Budget and 18 recommends its approval. 19 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 20 FY 2022 Sells District Economic Development Committee Enterprise Renovations 21 Budget effective October 1, 2021 in the amount of \$484,934.00, which shall be 22 funded by the Sells District Economic Development Account with Morgan Stanley 23 Smith Barney. 24 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2022 Sells 25 District Economic Development Committee Enterprise Renovations Budget shall 26 be managed and expended in accordance with Article IX, Section 7 of the 27 Constitution of the Tohono O'odham Nation and the Nation's laws, provided that 28 any amendments or modifications shall be authorized under District Council 29 resolution and submitted for prior approval by the Tohono O'odham Legislative 30 Council. 31
