The management of these funds shall be only by 6 a treasurer or other authorized officer of the district council who has 7 furnished a surety bond satisfactory to the treasurer of the Tohono 8 O'odham Nation, and all expenditures of these funds shall be by checks 9 signed by such treasurer or other authorized officer and the chairman or 10 vice chairman of the district council. 11 : and 12 WHEREAS. by Sells District Council Resolution No. SD-127-21, the Sells District has 13 authorized the FY 2022 Sells District Administration Donation Budget, which is 14 incorporated by this reference in the amount of \$1,000.00; and 15 WHEREAS the Budget and Finance Committee has reviewed the FY 2022 Sells District 16 Administration Donation Budget and recommends its approval. 17 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 18 FY 2022 Sells District Administration Donation Budget in the amount of \$1,000.00. 19 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2022 Sells 20 District Administration Donation Budget shall be managed and expended in 21 accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham 22 Nation and the Nation's laws, provided that any amendments or modifications 23 shall be authorized under District Council resolution and submitted for prior 24 approval by the Tohono O'odham Legislative Council. 25 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12^{TH} 26 day of JANUARY, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-27 AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by. 28 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono 29 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -30 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
