1	WHEREAS,	the Constitution of the Tohono O'odham Nation (Nation) vests the Legislative
2	1	Council with the authority "to promote, protect and provide for public health
3]	peace, morals, education and general welfare of the Tohono O'odham Nation and
4		its members" (Constitution, Article VI, Section 1(c)(2)) and "to authorize, charter
5		and regulate public or private corporations and associations whether organized
6	:	for profit, or for non-profit or charitable purposes" (Constitution, Article VI,
7		Section 1(b); and
8	WHEREAS,	the Nation's executives seek approval to create a Limited Liability Company (LLC)
9		to: (1) pursue the Nation's goal of economic self-sufficiency, self-governance and
10		self-determination; and (2) to carry out all actions necessary to acquire lands in
11		Mexico that are considered to be the traditional homelands of the Tohono
12		O'odham people and to promote tribal and economic development within these
13		lands; and
14	WHEREAS,	it is recommended that the LLC be formed under the laws of the State of Delaware
15		and structured as follows: (1) it will be a sole-member LLC wholly-owned by the
16	:	Nation; (2) it will be both a subordinate economic organization and an arm of the
17	ı L	Nation; (3) the Nation shall have exclusive and complete authority and discretion
18		to manage the operations and affairs of the LLC and to make all decisions
19		regarding the business of the LLC; (4) it will share the Nation's sovereign
20		immunity; (5) the LLC must make an annual report to the Nation's Legislative
21		Council; and (6) the Nation will adopt a Limited Liability Company Agreement
22		governing the LLC's internal business operations and outlining its rules,
23		regulations and provisions in substantially the same form as attached hereto in
24		Exhibit A; and
25	WHEREAS,	the Agricultural and Natural Resources Committee has reviewed this Resolution
26		and recommends its approval.
27	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:
28		1. Approves the creation of a Limited Liability Company under the laws of the
29		State of Delaware as described herein and directs the Nation to adopt a
30		Limited Liability Company Agreement governing the LLC's internal
31		business operations and outlining its rules, regulations and provisions in

substantially the same form as attached hereto in Exhibit A.
