

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Tohono O'odham Nation Coronavirus Relief Fund
Budget Amendment No. 3)**

RESOLUTION NO. 22-035

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2021 Tohono O'odham Nation Coronavirus Relief Fund Budget in the**
8 **amount of \$61,115,398.00 was approved by Resolution No. 20-226, and**
9 **subsequently amended by Resolution Nos. 21-018 and 21-108; and**

10 **WHEREAS, the Executive Branch has prepared and submitted for review and approval its FY**
11 **2022 Tohono O'odham Nation Coronavirus Relief Fund Budget Amendment No. 3,**
12 **which is incorporated by this reference and which will adjust operational and/or**
13 **personnel line items; and**

14 **WHEREAS, the FY 2022 Tohono O'odham Nation Coronavirus Relief Fund Budget**
15 **Amendment No. 3 will not change the original budget amount of \$61,115,398.00,**
16 **but will extend the budget term from ending on December 31, 2021 to September**
17 **30, 2022; and**

18 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2022 Tohono O'odham**
19 **Nation Coronavirus Relief Fund Budget Amendment No. 3 and recommends its**
20 **approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
22 **FY 2022 Tohono O'odham Nation Coronavirus Relief Fund Budget Amendment**
23 **No. 3 effective March 1, 2020 through September 30, 2022, which will not change**
24 **the original budget amount of \$61,115,398.00.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
26 **Nation chairperson or any designated official is authorized to administer and**
27 **expend the FY 2022 Tohono O'odham Nation Coronavirus Relief Fund Budget as**
28 **amended, provided that any amendments or modifications shall be submitted**
29 **for prior approval by the Tohono O'odham Legislative Council.**
