

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Recognition of Relinquishment from membership in the Tohono O'odham
Nation for the month of February 2022)**

RESOLUTION NO. 22-043

1 **WHEREAS, Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation vests the**
2 **Tohono O'odham Legislative Council with the power to "enact laws and**
3 **ordinances governing the enrollment and adoption of members and the**
4 **relinquishment and loss of membership"; and**

5 **WHEREAS, in accordance with the Tohono O'odham Nation's Enrollment Ordinance,**
6 **Ordinance No. 05-81 as amended the Enrollment Committee has received a**
7 **written statement from 01 tribal member who has expressed their intent to**
8 **relinquish their membership with the Tohono O'odham Nation and the member**
9 **is identified in the February 2022 Relinquishment List, which is incorporated by**
10 **this reference; and**

11 **WHEREAS, pursuant to Article IX Section 1 of the Enrollment Ordinance,**
12 **A member of the Nation may relinquish his membership in the**
13 **Nation by submitting a written statement clearly expressing an**
14 **intent to relinquish his membership to the Council, a copy of**
15 **which must be served on the committee. The written statement**
16 **must be signed by the person wishing to relinquish his membership**
17 **or, if a minor or incompetent, by the parent(s), guardian or other**
18 **person legally authorized to act on his behalf. Relinquishment**
19 **does not require the approval of the Council, but is effective upon**
20 **receipt of the statement by the Council and cannot be subsequently**
21 **denied. Upon recognition by the Council that the individual has**
22 **renounced his membership, his name shall be deleted from the**
23 **membership roll.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
25 **recognizes that one individual identified in the February 2022 Relinquishment**
26 **List has relinquished their membership in the Tohono O'odham Nation and**
27 **orders the removal of their name from the Nation's membership roll.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH**
29 **day of FEBRUARY, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**
30 **~~0~~ AGAINST; ~~0~~ NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by,**
31 **Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation, adopted by the**
32 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
34 **18, 1934 (48 Stat.984).**




