13	WHEREAS,	the Enrollment Program has determined that a number of resolutions approving				
14		membership and adoption applications misspelled or incorrectly listed the				
15		names of members and/or incorrectly listed enrollment numbers; and				
16	WHEREAS,	the Enrollment Program recommends that Resolution Nos. 127-83, 01-416, 04-				
17		212, 04-291, 04-438, 09-101, and 21-445 be amended to reflect the correct names				
18		and/or enrollment numbers for the members identified in the February 2022				
19		Corrected Enrollment Resolution Summary, which is incorporated by this				
20		reference.
