WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "promote, protect and provide for public health, peace, morals, education and general welfare of the Tohono O'odham Nation and its members" and to "provide for, appoint, or provide for the appointment of, and prescribe the duties and powers of committees, boards, officers and agents" (Constitution of the Tohono O'odham Nation, Article VI, Section 1(c)(2) and Section 1(b)); and

WHEREAS, the Tohono O'odham Ki:ki Association ("TOKA") Board of Directors consists of five voting members appointed by the Tohono O'odham Legislative Council who shall serve staggered four year terms or until their successors are appointed, with no more than two members' terms ending in a single year, and whose terms shall commence on March 1 and end on the last day of February (18 Tohono O'odham Code Chapter 1, Article V, Section 1(a)); and

WHEREAS, Board members shall have sufficient education and experience in housing, construction, business, and finance to provide oversight of the TOKA in order to achieve the TOKA's mission of providing safe, affordable, and well-constructed housing (18 Tohono O'odham Code Chapter 1, Article V, Section 1(b)); and

WHEREAS, Cachora Standifer was appointed to the TOKA Board of Directors by Resolution No. 16-386 for a term ending February 28, 2019 and he continues to serve until his successor is appointed; and

WHEREAS, the Housing Committee has interviewed and recommends the appointment of Cachora Standifer, a Nation's member with sufficient education and experience, to the TOKA Board of Directors for a term beginning on March 1, 2022 and ending February 28, 2025 or until his successor is appointed; and

WHEREAS, in accordance with the Board Appointment Guidelines, the Rules Committee has reviewed TOKA Board of Directors candidate Cachora Standifer's background information, including his background investigation report, and recommends moving his appointment forward to the full Legislative Council.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council appoints Cachora Standifer to the TOKA Board of Directors for a term beginning on March 1, 2022 and ending February 28, 2025 or until his successor is appointed.


