

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Attorney Contract between the Tohono O'odham Nation
and Clark Law Firm, P.C.)**

RESOLUTION NO. 22-066

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the power to “employ legal counsel for the protection and advancement of the**
3 **rights of the Tohono O'odham Nation . . .” (Constitution of the Tohono O'odham**
4 **Nation, Article VI, Section 2(a)); and**

5 **WHEREAS, the Human Resources Department should have independent legal**
6 **representation for employment issues for which the Office of Attorney General is**
7 **unable to provide legal advice due to conflicts of interest; and**

8 **WHEREAS, the Human Resources Department has determined that additional legal**
9 **assistance is required during the current fiscal year with regard to employment**
10 **issues; and**

11 **WHEREAS, the Human Resources Department has prepared and submitted for review and**
12 **approval the FY 2022 Attorney Contract between the Tohono O'odham Nation and**
13 **Clark Law Firm, P.C. (“Attorney Contract”), which is incorporated by this**
14 **reference, to provide legal representation to the Human Resources Department;**
15 **and**

16 **WHEREAS, the Human Resources Development and Domestic Affairs Committees have**
17 **reviewed the Attorney Contract and recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **FY 2022 Attorney Contract between the Tohono O'odham Nation and Clark Law**
20 **Firm, P.C., effective October 1, 2021 through September 30, 2022, in the amount of**
21 **\$15,000.00.**


22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Chairman of the**
23 **Nation or any designated official is authorized to execute the Attorney Contract in**
24 **substantially the form attached.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17TH**
26 **day of FEBRUARY, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;**
27 **-0- AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by,**
28 **Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the**
29 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat.984).**




