

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Department of Health and Human Services Inter Tribal Council
of Arizona Women, Infants, and Children Program Budget Amendment No. 1)**

RESOLUTION NO. 22-074

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2022 Department of Health and Human Services Women, Infants, and**
8 **Children Program Inter Tribal Council of Arizona Grant Budget in the amount of**
9 **\$129,520.00 was approved by Resolution No. 21-323; and**

10 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**
11 **review and approval its FY 2022 Inter Tribal Council of Arizona ("ITCA") Women,**
12 **Infants, and Children ("WIC") Program Budget Amendment No. 1, which is**
13 **incorporated by this reference and which will adjust operational and/or**
14 **personnel line items; and**

15 **WHEREAS, the FY 2022 Department of Health and Human Services ITCA WIC Program Budget**
16 **Amendment No. 1 will increase the FY 2022 Department of Health and Human**
17 **Services ITCA WIC Budget by \$36,900.00 from \$129,520.00 to \$166,420.00; and**

18 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
19 **reviewed the FY 2022 Department of Health and Human Services ITCA WIC**
20 **Program Budget Amendment No. 1 and recommend its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
22 **FY 2022 Department of Health and Human Services ITCA WIC Program Budget**
23 **Amendment No. 1 effective October 1, 2021, which includes a \$36,900.00 increase**
24 **from \$129,520.00 to \$166,420.00 that shall be funded by the Inter Tribal Council of**
25 **Arizona award.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
27 **Nation chairperson or any designated official is authorized to administer and**
28 **expend the FY 2022 Department of Health and Human Services Inter Tribal**
29 **Council of Arizona Women, Infants, and Children Program Budget as amended,**
30 **provided that any amendments or modifications shall be submitted for prior**
31 **approval by the Tohono O'odham Legislative Council.**




