14	WHEREAS,	the Budget and Finance Committee has reviewed the FY 2022 Executive Branch
15		American Rescue Plan Act Budget and recommends its approval.
16	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
17		FY 2022 Executive Branch American Rescue Plan Act Budget effective March 11,
18		2021 through December 31, 2024 in the amount of \$170,056,409.00 to be funded by
