RESOLUTION NO. 22-085

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members**
3 **(Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and**
4 **Article VI, Section 1(h)); and**

5 **WHEREAS, pursuant to Articles VI and VII of the Nation's Enrollment Ordinance, the**
6 **Enrollment Committee shall review membership applications and make a**
7 **written recommendation to the Tohono O'odham Legislative Council to approve**
8 **or reject the application (14 Tohono O'odham Code Chapter 1 - Enrollment**
9 **Ordinance); and**

10 **WHEREAS, pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono**
11 **O'odham Legislative Council shall determine eligibility for membership or**
12 **adoption; and**

13 **WHEREAS, the Enrollment Program has received official documents reflecting the legal**
14 **name changes of enrolled members as a result of marriage, divorce, legal**
15 **adoption, or for other reasons; and**

16 **WHEREAS, the Enrollment Program recommends that Resolution Nos. 32-80, 115-82, 150-82,**
17 **164-83, 197-83, 334-88, 66-89, 364-89, 91-108, 92-450, 94-109, 97-256, 97-350, 98-**
18 **083, 98-123, 98-429, 99-311, 01-543, 02-280, 07-739, 09-477, and 12-085 be amended**
19 **to reflect the amended names for the members identified in the March 2022**
20 **Amended Enrollment Resolution Summary, which is incorporated by this**
21 **reference.**

22 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**
23 **Nos. 32-80, 115-82, 150-82, 164-83, 197-83, 334-88, 66-89, 364-89, 91-108, 92-450,**
24 **94-109, 97-256, 97-350, 98-083, 98-123, 98-429, 99-311, 01-543, 02-280, 07-739, 09-**
25 **477, and 12-085 are amended upon the effective date of those resolutions to**
26 **reflect the legal name changes of members identified in the March 2022 Amended**
27 **Enrollment Resolution Summary.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH**
29 **day of MARCH, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by,**
31 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham**
32 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
33 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
34 **16 of the Act of June 18, 1934 (48 Stat.984).**




