1	WHEREAS,	the Tohono O'odham Legislative Council is authorized "to manage any funds
2		within the exclusive control of the Tohono O'odham Nationand to appropriate
3		these funds for the benefit of the nation and its members" provided that "[a]ll
4		expenditures of these funds shall be pursuant to appropriations or budgets"
5		authorized by resolutions or ordinance (Constitution of the Tohono O'odham
6		Nation, Article VI, Section 1(d)(2)); and
7	WHEREAS,	the Tohono O'odham Legislative Council enacted Resolution No. 95-562
8		"Recognition of the O'odham in Mexico Communities and Traditional
9		Government" to address issues for the Tohono O'odham members who reside on
10		the Tohono O'odham ancestral land in Mexico; and
11	WHEREAS,	subsequent to Tohono O'odham Legislative Council Resolution No. 95-562, the
12		Tohono O'odham Legislative Council passed Resolution Nos. 05-725, 13-444, 16-
13		160, 18-049, and 19-417, which updated and/or approved communities and
14		Tohono O'odham leadership and continues to recognize the Traditional
15		O'odham Leaders and their traditional form of government; and
16	WHEREAS,	the Traditional O'odham Leaders of the 17 communities of Sonora, Mexico,
17		respectfully submitted for consideration, a budget to address some of the much
18		needed assistance to carry on the functions and endeavors of the Traditional
19		O'odham Leaders of Mexico for the benefit of the O'odham of Sonoran, Mexico and
20		aboard; and
21	WHEREAS,	the Executive Branch has prepared and submitted for review and approval its FY
22		2022 Traditional O'odham Leaders Budget, which is incorporated by this
23		reference, in the amount of \$180,435.80 to be funded by the Nation's general fund
24	[surplus; and
25	WHEREAS,	the Domestic Affairs and Budget and Finance Committees have reviewed the FY
26		2022 Executive Branch Traditional O'odham Leaders Budget and recommend its
27		approval.
28	NOW, THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
29		FY 2022 Traditional O'odham Leaders Budget retroactively effective October 1,
30		2021 in the amount of \$180,435.80 to be funded from the general fund surplus.
31	BE IT FINAL	LY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
32		Nation chairperson or any designated official is authorized to administer and
33		expend the FY 2022 Traditional O'odham Leaders Budget, provided that any
