

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the U.S. Department of Health and Human Services Administration for
Children and Families MaryLee Allen Promoting Safe and Stable Families Program
Award and FY 2022 Department of Health and Human Services MaryLee Allen
Promoting Safe and Stable Families Program Budget)**

RESOLUTION NO. 22-093

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services applied for and was awarded the
8 U.S. Department of Health and Human Services Administration for Children and
9 Families MaryLee Allen Promoting Safe and Stable Families Program Award No.
10 21PCAZFPSC in the amount of \$50,955.00; and

11 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
12 review and approval its FY 2022 MaryLee Allen Promoting Safe and Stable
13 Families Program Budget, which is incorporated by this reference, in the amount
14 of \$50,955.00, to be funded by the Nation's general fund pending reimbursement
15 from the grantor, the U.S. Department of Health and Human Services; and

16 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
17 reviewed the FY 2022 Department of Health and Human Services MaryLee Allen
18 Promoting Safe and Stable Families Program Budget and recommend approval.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves:

- 20 1. the U.S. Department of Health and Human Services Administration for
21 Children and Families MaryLee Allen Promoting Safe and Stable Families
22 Program Award; and
- 23 2. the FY 2022 Department of Health and Human Services MaryLee Allen
24 Promoting Safe and Stable Families Budget effective October 1, 2021 in the
25 amount of \$50,955.00, which shall be funded by the Nation's general fund
26 pending reimbursement from the grantor, the U.S. Department of Health and
27 Human Services.

28 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
29 Nation chairperson or any designated official is authorized to administer
30 and expend the FY 2022 Department of Health and Human Services MaryLee Allen
31 Promoting Safe and Stable Families Budget, provided that any amendments or

9 18, 1934 (48 Stat.984).
