

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 20-335 "Approving FY 2020 Tohono O'odham Nation Healthcare CARES Act Budgets" to Extend the FY 2021 COVID-19 Testing Budget Authority into FY 2022)

RESOLUTION NO. 22-095

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2) and (3)); and

7 **WHEREAS,** the FY 2021 Tohono O'odham Nation Healthcare CARES Act COVID-19 Testing
8 Budget in the amount of \$530,430.00 was approved by Resolution No. 20-335; and

9 **WHEREAS,** Tohono O'odham Nation Healthcare is requesting the budget term be extended
10 for the FY 2021 Tohono O'odham Nation Healthcare CARES Act COVID-19 Testing
11 Budget in amount of \$530,430.00, which expired September 30, 2021, into FY 2022
12 to expend available funds; and

13 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
14 reviewed the amending resolution and recommend its approval.

15 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council amends
16 Resolution No. 20-335 to extend the budget authority for the FY 2021 Tohono
17 O'odham Nation Healthcare CARES Act COVID-19 Testing Budget in the amount of
18 \$530,430.00 through September 30, 2022.

19 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
20 Nation chairperson or any designated official is authorized to administer and
21 expend the FY 2021 Tohono O'odham Nation Healthcare CARES Act COVID-19
22 Testing Budget for the period of March 1, 2020 through September 30, 2022, and
23 the Accounting Department is authorized to post the unexpended balances of the
24 budget as of September 30, 2021 as a carry forward into fiscal year 2022 beginning
25 March 1, 2020, provided that any amendments or modifications shall be
26 submitted for prior approval by the Tohono O'odham Legislative Council.

27 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH
28 day of MARCH, 2022 at a meeting at which a quorum was present with a vote of 2,975.4 FOR; -0-
29 AGAINST; -0- NOT VOTING; and 242.6[06] ABSENT, pursuant to the powers vested in the Council
30 by, Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted
31 by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy
32 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the
33 Act of June 18, 1934 (48 Stat.984).
