

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Appointing Marcos Ysmael to the Tohono O'odham Ki:Ki Association Board of Directors)**

**RESOLUTION NO. 22-097**

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to "promote,  
2 protect and provide for public health, peace, morals, education and general  
3 welfare of the Tohono O'odham Nation and its members" and to "provide for,  
4 appoint, or provide for the appointment of, and prescribe the duties and powers  
5 of committees, boards, officers and agents" (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(c)(2) and Section 1(b)); and

7 **WHEREAS,** the Tohono O'odham Ki:ki Association ("TOKA") Board of Directors consists of five  
8 voting members appointed by the Tohono O'odham Legislative Council who shall  
9 serve staggered four year terms or until their successors are appointed, with no  
10 more than two members' terms ending in a single year, and whose terms shall  
11 commence on March 1 and end on the last day of February (18 Tohono O'odham  
12 Code Chapter 1, Article V, Section 1(a)); and

13 **WHEREAS,** Board members shall have sufficient education and experience in housing,  
14 construction, business, and finance to provide oversight of the TOKA in order to  
15 achieve the TOKA's mission of providing safe, affordable, and well-constructed  
16 housing (18 Tohono O'odham Code Chapter 1, Article V, Section 1(b)); and

17 **WHEREAS,** the Housing Committee has interviewed and recommends the appointment of  
18 Marcos Ysmael, a non-member with sufficient education and experience, to the  
19 TOKA Board of Directors for a term beginning on March 1, 2022 and ending  
20 February 28, 2026 or until his successor is appointed; and


21 **WHEREAS,** in accordance with the Board Appointment Guidelines, the Rules Committee has  
22 reviewed TOKA Board of Directors candidate Marcos Ysmael's background  
23 information, including his background investigation report, and recommends  
24 moving his appointment forward to the full Legislative Council.

25 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council appoints  
26 Marcos Ysmael to the TOKA Board of Directors for a term beginning on March 1,  
27 2022 and ending February 28, 2026 or until his successor is appointed.


28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup>**  
29 **day of MARCH, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**  
30 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by,**  
31 **Article VI, Section 1(b) and 1(c)(2) of the Constitution of the Tohono O'odham Nation, adopted by**  
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
34 **18, 1934 (48 Stat.984).**




