NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 18 19 FY 2021-2025 Pisinemo District American Rescue Plan Act Budget in the amount 20 of \$2,983,501.00 effective March 11, 2021 to December 31, 2024, which shall be 21 funded by American Rescue Plan Act funds and which may be expended until 22 December 31, 2026, provided that the funds are obligated by December 31, 2024.
