

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Gu Achi District Tower User Funds Budget)**

RESOLUTION NO. 22-100

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** by the Gu Achi District Council Resolution No.0222-075, the Gu Achi District has
13 authorized the FY 2022 Gu Achi District Tower User Funds Budget, which is
14 incorporated by this reference in the amount of \$231,739.95; and

15 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2022 Gu Achi District
16 Tower User Funds Budget and recommends its approval.


17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
18 FY 2022 Gu Achi District Tower User Funds Budget in the amount of \$231,739.95
19 effective October 1, 2021, which shall be funded from the Tower User fees.

20 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2022 Gu Achi
21 District Tower User Funds Budget shall be managed and expended in accordance
22 with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and
23 the Nation's laws, provided that any amendments or modifications shall be
24 authorized under District Council resolution and submitted for prior approval by
25 the Tohono O'odham Legislative Council.

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
27 **day of MARCH, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by,**
29 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
30 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
31 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**


