

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Fiscal Year 2022 Tohono O'odham Nation Healthcare American  
Rescue Plan Act Lost Reimbursement Budget)**

**RESOLUTION NO. 22-107**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham Nation Healthcare's ("TONHC") Governing Body has**  
8 **prepared and submitted for review and approval its Fiscal Year 2022 American**  
9 **Rescue Plan Act ("ARPA") Lost Reimbursement Budget in the amount of**  
10 **\$19,034,930.00, which is incorporated herein and attached hereto as Exhibit A,**  
11 **and which shall be funded by the U.S. Department of Health and Human Services;**  
12 **and**

13 **WHEREAS, the Nation agrees to use these funds in the manner required by ARPA Section**  
14 **11001(a)(1)(A) and 25 U.S.C. § 1621f; and**

15 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
16 **reviewed this Fiscal Year 2022 ARPA Lost Reimbursement Budget and**  
17 **recommends its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
19 **Fiscal Year 2022 Tohono O'odham Nation Healthcare American Rescue Plan Act**  
20 **Budget in the amount of \$19,034,930.00, which became effective on October 1,**  
21 **2021 and can continue to be used through September 30, 2022, and which shall**  
22 **be funded by the U.S. Department of Health and Human Services Administration.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes the Nation's**  
24 **Chairman, Ned Norris, Jr., or his official designee to sign all documents and**  
25 **undertake all actions necessary to carry out the purposes of this resolution,**  
26 **provided that any additional amendments or modifications shall be submitted**  
27 **for prior approval to the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup>**  
29 **day of MARCH, 2022 at a meeting at which a quorum was present with a vote of 3,001.4 FOR; -0-**  
30 **AGAINST; 216.6[01] NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council**  
31 **by, Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**  
32 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
33 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**  
34 **Act of June 18, 1934 (48 Stat.984).**
