15	WHEREAS,	the Health and Human Services and Budget and Finance Committees have
16		reviewed this Fiscal Year 2022 ARPA Lost Reimbursement Budget and
17		recommends its approval.

19		Fiscal Year 2022 Tohono O'odham Nation Healthcare American Rescue Plan Act
20		Budget in the amount of \$19,034,930.00, which became effective on October 1,
21		2021 and can continue to be used through September 30, 2022, and which shall
22		be funded by the U.S. Department of Health and Human Services Administration.
