13	WHEREAS,	the Enrollment Program has determined that a number of resolutions approving
14		membership and adoption applications misspelled or incorrectly listed the
15		names of members and/or incorrectly listed enrollment numbers; and
16	WHEREAS,	the Enrollment Program recommends that Resolution Nos. 98-174, 04-109, 04-
17		291, 04-508, 04-659, 05-054, 05-368, 05-472, 05-653, 05-711, 07-706, and 22-042 be
18		amended to reflect the correct names and/or enrollment numbers of members
19		identified in the April 2022 Corrected Enrollment Resolution Summary, which is
20		incorporated by this reference.
