

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Department of Health and Human Services Food Distribution
Program USDA Food Distribution Carry Over Budget)**

RESOLUTION NO. 22-135

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2021 Department of Health and Human Services Food Distribution
8 Program USDA Food Distribution Budget in the amount of \$399,126.00 was
9 approved by Resolution No. 20-278; and

10 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
11 review and approval its FY 2022 Food Distribution Program USDA Food Carry Over
12 Budget, which is incorporated by this reference, in the amount of \$29,451.78 to be
13 funded from the Nation's general fund pending reimbursement from the grantor,
14 the USDA; and

15 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
16 reviewed the FY 2022 Department of Health and Human Services Food
17 Distribution Program USDA Food Distribution Carry Over Budget and
18 recommend its approval.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
20 FY 2022 Department of Health and Human Services Food Distribution Program
21 USDA Food Distribution Carry Over Budget effective October 1, 2021 in the
22 amount of \$29,451.78 which shall be funded by the Nation's general fund pending
23 reimbursement from the grantor, the USDA.

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
25 Nation chairperson or any designated official is authorized to administer and
26 expend the FY 2022 Department of Health and Human Services Food Distribution
27 Program USDA Food Distribution Carry Over Budget, provided that any
28 amendments or modifications shall be submitted for prior approval by the
29 Tohono O'odham Legislative Council.




