

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Baboquivari District South Komelic Community Budget Amendment No. 1)

RESOLUTION NO. 22-139

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2022 Baboquivari District Budget in the amount of \$5,193,817.36 was
13 authorized by Baboquivari District Council Resolution No. 2021-B-123 and
14 approved by Legislative Council Resolution No. 21-366 and subsequently
15 amended by Resolution Nos. 21-462 and 22-049; and

16 **WHEREAS,** by Baboquivari District Council Resolution No. 2022-B-14, the Baboquivari
17 District has authorized and submitted for review and approval its FY 2022
18 Baboquivari District South Komelic Community Budget Amendment No. 1, which
19 is incorporated by this reference and which will adjust operational and/or
20 personnel line items; and

21 **WHEREAS,** the FY 2022 Baboquivari District South Komelic Community Budget Amendment
22 No. 1 will increase the South Komelic Community Budget by \$16,646.39 from
23 \$499,115.43 to \$515,761.82 that shall be funded by FY 2020 Mining Royalty funds;
24 and

25 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2022 Baboquivari District
26 South Komelic Community Budget Amendment No. 1 and recommends its
27 approval.

28 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
29 FY 2022 Baboquivari District South Komelic Community Budget Amendment No.
30 1 effective October 1, 2021, which includes a \$16,646.39 increase from \$499,115.43
31 to \$515,761.82 that shall be funded by FY 2020 Mining Royalty funds.

32 **BE IT FURTHER RESOLVED** by the Tohono O'odham Legislative Council that the FY Baboquivari
33 District Budgets is increased by \$16,646.39 from \$5,193,817.36 to \$5,210,463.75.



The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH day of APRIL, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by, Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
