

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Department of Health and Human Services Division of Senior Services
Title VI Part A, Title VI Part C, and Nutrition Services Incentive Program Budgets)

RESOLUTION NO. 22-148

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d) (2)); and**

7 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**
8 **review and approval its FY 2023 Division of Senior Services Title VI Part A Budget**
9 **in the amount of \$186,930.00; Title VI Part C Budget in the amount of \$68,680.00;**
10 **and Nutrition Services Incentive Program ("NSIP") Budget in the amount of**
11 **\$9,400.00, which are incorporated by these references, to be funded by the**
12 **Nation's general fund pending reimbursement from the grantor, the**
13 **Administration for Community Living, pursuant to Title VI of the Older**
14 **Americans Act of 1978; and**

15 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
16 **reviewed the FY 2023 Department of Health and Human Services Division of**
17 **Senior Services Title VI Part A, Title VI Part C and NSIP Budgets and recommend**
18 **their approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **FY 2023 Department of Health and Human Services Division of Senior Services**
21 **Title VI Part A Budget in the amount of \$186,930.00; Title VI Part C Budget in the**
22 **amount of \$68,680.00; and NSIP Budget in the amount of \$9,400.00 for the period**
23 **beginning April 1, 2022 to March 31, 2023, which shall be funded by the Nation's**
24 **general fund pending reimbursement from the grantor, the Administration for**
25 **Community Living, pursuant to Title VI of the Older Americans Act of 1978.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
27 **Nation chairperson or any designated official is authorized to administer and**
28 **expend the FY 2023 Department of Health and Human Services Division of Senior**
29 **Services Title VI Part A, Title VI Part C and NSIP Budgets, provided that any**
30 **amendments or modifications shall be submitted for prior approval by the**
31 **Tohono O'odham Legislative Council.**




