

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution Nos. 98-83, 184-83, 27-84, 99-140, 04-350, 04-659,
18-220, 19-386, and 20-370 to Reflect Legal Name Changes of Enrolled Members)

RESOLUTION NO. 22-193

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to enact laws
2 and ordinances governing the enrollment and adoption of members
3 (Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and
4 Article VI, Section 1(h)); and

5 **WHEREAS,** pursuant to Articles VI and VII of the Nation's Enrollment Ordinance, the
6 Enrollment Committee shall review membership applications and make a
7 written recommendation to the Tohono O'odham Legislative Council to approve
8 or reject the application (14 Tohono O'odham Code Chapter 1 - Enrollment
9 Ordinance); and

10 **WHEREAS,** pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono
11 O'odham Legislative Council shall determine eligibility for membership or
12 adoption; and

13 **WHEREAS,** the Enrollment Program has received official documents reflecting the legal
14 name changes of enrolled members as a result of marriage, divorce, legal
15 adoption, or for other reasons; and

16 **WHEREAS,** the Enrollment Program recommends that Resolution Nos. 98-83, 184-83, 27-84,
17 99-140, 04-350, 04-659, 18-220, 19-386, and 20-370 be amended to reflect the
18 amended names of members identified in the June 2022 Amended Enrollment
19 Resolution Summary, which is incorporated by this reference.

20 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that Resolution
21 Nos. 98-83, 184-83, 27-84, 99-140, 04-350, 04-659, 18-220, 19-386, and 20-370 are
22 amended upon the effective date of those resolutions to reflect the legal name
23 changes of members identified in the June 2022 Amended Enrollment Resolution
24 Summary.

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
26 **day of JUNE, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by,**
28 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham**
29 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
30 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
31 **16 of the Act of June 18, 1934 (48 Stat.984).**
