13	WHEREAS,	the Enrollment Program has received official documents reflecting the legal
14		name changes of enrolled members as a result of marriage, divorce, legal
15		adoption, or for other reasons; and
16	WHEREAS,	the Enrollment Program recommends that Resolution Nos. 98-83, 184-83, 27-84,
17		99-140, 04-350, 04-659, 18-220, 19-386, and 20-370 be amended to reflect the
18		amended names of members identified in the June 2022 Amended Enrollment
19		Resolution Summary, which is incorporated by this reference.
