

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2023 Department of Education Child Care Services Title XX Budget)**

**RESOLUTION NO. 22-199**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Education has prepared and submitted for review and  
8 approval its FY 2023 Child Care Services Title XX Budget, which is incorporated by  
9 this reference, in the amount of \$104,203.00 to be funded from the Arizona  
10 Department of Economic Security Planned Social Services Block Grant Title XX  
11 Program for a period beginning July 01, 2022 through June 30, 2023; and

12 **WHEREAS,** the Human Resources Development and Budget and Finance Committees have  
13 reviewed the FY 2023 Department of Education Child Care Services Title XX  
14 Budget and recommend its approval.

15 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
16 FY 2023 Department of Education Child Care Services Title XX Budget effective  
17 July 1, 2022 in amount of \$104,203.00, which shall be funded by the Nation's  
18 general fund pending reimbursement from the grantor, Department of  
19 Economic Security Planned Social Services Block Grant Title XX Program.

20 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
21 Nation chairperson or any designated official is authorized to administer and  
22 expend the FY 2023 Department of Education Child Care Services Title XX Budget,  
23 provided that any amendments or modifications shall be submitted for prior  
24 approval by the Tohono O'odham Legislative Council.

25 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup>  
26 day of JUNE, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-  
27 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by,  
28 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by  
29 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
30 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
31 18, 1934 (48 Stat.984).






