20	WHEREAS,	by Resolution No. 21-427, the Legislative Council repealed Resolution No. 20-121
21		"Suspending Timeframes in the Appointed Officers Law Due to the COVID-19
22		Pandemic" and authorized:
23		1. an appointee who has undergone the Appointed Officers process pursuant
24		to Section 4003(B) and (C) to proceed to the Legislative Council, provided
25		that the background investigation report shall be updated and reviewed
26		by the respective oversight committee prior to the appointee's interview
