

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Department of Education One Stop Public Law 102-477
Budget Amendment No. 1)**

RESOLUTION NO. 22-207

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2022 Department of Education One Stop Division Public Law 102-477
8 Budget in the amount of \$1,141,042.67 was approved by Resolution No. 21-304;
9 and

10 **WHEREAS,** the Department of Education has prepared and submitted for review and
11 approval its FY 2022 Department of Education One Stop Public Law 102-477
12 Budget Amendment No. 1, which is incorporated by this reference and which will
13 adjust operational and/or personnel line items; and

14 **WHEREAS,** the FY 2022 Department of Education One Stop Public Law 102-477 Budget
15 Amendment No. 1 will not increase the FY 2022 Department of Education One Stop
16 Division Public Law 102-477 Budget amount of \$1,141,042.67; and

17 **WHEREAS,** the Human Resources Development Committee and Budget and Finance
18 Committee have reviewed the FY 2022 Department of Education One Stop Public
19 Law 102-477 Budget Amendment No. 1 and recommend its approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
21 FY 2022 Department of Education One Stop Public Law 102-477 Budget
22 Amendment No. 1 effective October 1, 2021, which will not increase the FY 2022
23 Department of Education One Stop Division Public Law 102-477 Budget amount
24 of \$1,141,042.67, which shall be funded by the Bureau of Indian Affairs 102-477
25 funding.

26 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
27 Nation chairperson or any designated official is authorized to administer and
28 expend the FY 2022 Department of Education One Stop Division Public Law 102-
29 477 Budget as amended, provided that any amendments or modifications shall
30 be submitted for prior approval by the Tohono O'odham Legislative Council.
