The management of these funds shall be only by a treasurer or other authorized officer of the district council who has 6 7 furnished a surety bond satisfactory to the treasurer of the Tohono 8 O'odham Nation, and all expenditures of these funds shall be by checks 9 signed by such treasurer or other authorized officer and the chairman or 10 vice chairman of the district council. 11 ; and 12 WHEREAS. the FY 2022 Gu-Vo District Budget in the amount of \$4,288,132.28 was authorized 13 by Gu-Vo District Council Resolution No. GV-21-077 and approved by Legislative 14 Council Resolution No. 21-380; and 15 by Gu-Vo District Council Resolution No. GV-22-046, the Gu-Vo District Council WHEREAS. 16 has authorized and submitted for review and approval its FY 2022 Pia-Oik Community Budget Amendment No. 1, which is incorporated by this reference 17 18 and which will adjust operational and/or personnel line items; and 19 WHEREAS. the FY 2022 Gu-Vo District Pia-Oik Community Budget Amendment No. 1 will not 20 change the FY 2022 Pia-Oik Community Budget amount of \$428,813.23; and 21 WHEREAS, the Budget and Finance Committee has reviewed the FY 2022 Gu-Vo District Pia-22 Oik Community Budget Amendment No. 1 and recommends its approval. 23 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 24 FY 2022 Gu-Vo District Pia-Oik Community Budget Amendment No. 1 effective 25 October 1, 2021, which will not change the FY 2022 Pia-Oik Community Budget 26 amount of \$428,813.23 nor the FY 2022 Gu-Vo District Budget amount of 27 \$4,288,132.28. 28 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2022 Gu-Vo 29 District Budget as amended shall be managed and expended in accordance with 30 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the 31 Nation's laws, provided that any amendments or modifications shall be 32 authorized under District Council resolution and submitted for prior approval by 33 the Tohono O'odham Legislative Council.
