(Amending Enrollment Resolution Nos. 138-81, 15-82, 27-84, 09-85, 91-308, 94-154,
99-360, 05-114, 05-711 and 17-259 to Reflect Legal Name Changes of Enrolled Members)

RESOLUTION NO. 22-211

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members**
3 **(Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and**
4 **Article VI, Section 1(h)); and**

5 **WHEREAS, pursuant to Articles VI and VII of the Nation's Enrollment Ordinance, the**
6 **Enrollment Committee shall review membership applications and make a**
7 **written recommendation to the Tohono O'odham Legislative Council to approve**
8 **or reject the application (14 Tohono O'odham Code Chapter 1 – Enrollment**
9 **Ordinance); and**

10 **WHEREAS, pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono**
11 **O'odham Legislative Council shall determine eligibility for membership or**
12 **adoption; and**

13 **WHEREAS, the Enrollment Program has received official documents reflecting the legal**
14 **name changes of enrolled members as a result of marriage, divorce, legal**
15 **adoption, or for other reasons; and**

16 **WHEREAS, the Enrollment Program recommends that Resolution Nos. 138-81, 15-82, 27-84,**
17 **09-85, 91-308, 94-154, 99-360, 05-114, 05-711 and 17-259 be amended to reflect the**
18 **amended names of members identified in the July 2022 Amended Enrollment**
19 **Resolution Summary, which is incorporated by this reference.**

20 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**
21 **Nos. 138-81, 15-82, 27-84, 09-85, 91-308, 94-154, 99-360, 05-114, 05-711 and 17-259**
22 **are amended upon the effective date of those resolutions to reflect the legal name**
23 **changes of members identified in the July 2022 Amended Enrollment Resolution**
24 **Summary.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH**
26 **day of JULY, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by,**
28 **Article II, Sections 1 and 2 and Article VI, Section 1(h) the Constitution of the Tohono O'odham**
29 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
30 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
31 **16 of the Act of June 18, 1934 (48 Stat.984).**






