

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 General Support Services Accounting Office Budget Amendment No. 1)

RESOLUTION NO. 22-218

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the General Support Services Accounting Office has prepared and submitted for**
8 **review and approval its FY 2022 Accounting Office Budget Amendment No. 1,**
9 **which is incorporated by this reference, in the amount of \$5,114,701.44 to be**
10 **funded from the Nation's general fund; and**

11 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2022 General Support**
12 **Services Accounting Office Budget Amendment No. 1 and recommend its**
13 **approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
15 **FY 2022 General Support Services Accounting Office Budget Amendment No. 1,**
16 **effective October 1, 2021, in amount of \$5,114,701.44, which shall be funded by the**
17 **Nation's general fund.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
19 **Nation chairperson or any designated official is authorized to administer and**
20 **expend the FY 2022 General Support Services Accounting Office Budget**
21 **Amendment 1, provided that any amendments or modifications shall be**
22 **submitted for prior approval by the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH**
24 **day of JULY, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by,**
26 **Article VI, Section 1(d)(2)and(3) the Constitution of the Tohono O'odham Nation, adopted by the**
27 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat.984).**


