

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Tohono O'odham Nation Healthcare Department of Information & Technology Third Party Budget Amendment No. 1)

RESOLUTION NO. 22-220

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Tohono O'odham Nation Health Care has prepared and submitted for review
8 and approval its FY 2022 Tohono O'odham Nation Healthcare Department of
9 Information & Technology Third Party Budget Amendment No. 1, which is
10 incorporated by this reference, in the amount of \$1,853,650.72 to be funded from
11 the Indian Health Service and third-party revenues; and

12 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
13 reviewed the FY 2022 Tohono O'odham Nation Healthcare Department of
14 Information & Technology Third Party Budget Amendment No. 1 and recommend
15 its approval.

16 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
17 FY 2022 Tohono O'odham Nation Healthcare Department of Information &
18 Technology Third Party Budget Amendment No. 1, effective October 1, 2021, in
19 amount of \$1,853,650.72 which shall be funded by the Indian Health Service and
20 third-party revenues.

21 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
22 Nation chairperson or any designated official is authorized to administer and
23 expend the FY 2022 Tohono O'odham Nation Healthcare Department of
24 Information & Technology Third Party Budget as amended, provided that any
25 amendments or modifications shall be submitted for prior approval by the
26 Tohono O'odham Legislative Council.

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH**
28 **day of JULY, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by,**
30 **Article VI, Section 1(d)(2)and(3) the Constitution of the Tohono O'odham Nation, adopted by the**
31 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat.984).**
