

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of an Intergovernmental Agreement between the City of Tolleson
and the Tohono O'odham Nation)

RESOLUTION NO. 22-221

1 **WHEREAS,** the Constitution of the Tohono O'odham Nation vests the Legislative Council with
2 the power "to consult, negotiate and conclude agreements and contracts on
3 behalf of the Tohono O'odham Nation with Federal, State and local governments
4 and other Indian tribes or their departments, agencies, or political subdivisions,
5 or with private persons or organizations on all matters within the authority of the
6 Tohono O'odham Council." (Constitution, Article VI, Section 1(f)); and

7 **WHEREAS,** the Tohono O'odham Nation entered into several Intergovernmental Agreements
8 with the City of Tolleson to provide Law Enforcement Services to the West Valley
9 Casino that were approved by Resolution Nos. 15-483, 16-381, 17-262 and 19-182;
10 and

11 **WHEREAS,** the most recent approved Intergovernmental Agreement expired June 20, 2020;
12 and

13 **WHEREAS,** the Tohono O'odham Nation has negotiated a new Intergovernmental Agreement
14 with the City of Tolleson that shall be effective January 1, 2022 through September
15 30, 2022 with a self-renewal on October 1, 2022 for an additional two years; and

16 **WHEREAS,** the Domestic Affairs Committee has reviewed the Intergovernmental Agreement
17 with the City of Tolleson and recommend its approval.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
19 Intergovernmental Agreement with the City of Tolleson, effective January 1, 2022,
20 in substantially the form attached, and authorizes the Chairman of the Nation to
21 execute it, provided that any amendments or modifications shall be submitted
22 for prior approval by the Tohono O'odham Legislative Council.

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH**
24 **day of JULY, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by,**
26 **Article VI, Section 1(f) the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
27 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
28 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
29 **(48 Stat.984).**


