

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022 Department of Public Safety Environmental Protection
Office Brownfields Budget Amendment No. 1)**

RESOLUTION NO. 22-224

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Tohono O'odham Legislative Council approved FY 2022 Department of Public
8 Safety Environmental Protection Office Brownfields Budget in the amount of
9 \$129,000.00 by Resolution No. 21-314; and

10 **WHEREAS,** the Department of Public Safety has prepared and submitted for review and
11 approval its FY 2022 Environmental Protection Office Brownfields Budget
12 Amendment No. 1, which is incorporated by this reference and which will adjust
13 operational and/or personnel line items; and

14 **WHEREAS,** the FY 2022 Department of Public Safety Environmental Protection Office
15 Brownfields Budget Amendment No. 1 will increase the FY 2022 Department of
16 Public Safety Environmental Protection Office Brownfields Budget by
17 \$117,314.59, from \$129,000.00 to \$246,314.59; and

18 **WHEREAS,** the Domestic Affairs and Budget and Finance Committees have reviewed the FY
19 2022 Department of Public Safety Environmental Protection Office Brownfields
20 Budget Amendment No.1 and recommend its approval.

21 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
22 FY 2022 Department of Public Safety Environmental Protection Office
23 Brownfields Budget Amendment No. 1 effective October 1, 2021, in the amount of
24 \$246,314.59, and which shall be funded by the U.S. Environmental Protection
25 Agency Assistant Agreement Grant under the Brownfields 128(a) Tribal Response
26 Program.

27 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
28 Nation chairperson or any designated official is authorized to administer and
29 expend the FY 2022 Department of Public Safety Environmental Protection Office
30 Brownfields Budget as amended, provided that any amendments or
31 modifications shall be submitted for prior approval by the Tohono O'odham
32 Legislative Council.
