

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2022 Department of Health and Human Services Tribal Opioid**  
**Response Program Budget Amendment No. 1)**

**RESOLUTION NO. 22-234**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2022 Department of Health and Human Services Tribal Opioid Response  
8 Program Budget in the amount of \$700,000.00 was approved by Resolution No.  
9 22-134; and

10 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for  
11 review and approval its FY 2022 Tribal Opioid Response Program Budget  
12 Amendment No. 1, which is incorporated by this reference, and which will adjust  
13 operational line items and increase indirect costs; and

14 **WHEREAS,** the FY 2022 Department of Health and Human Services Tribal Opioid Response  
15 Program Budget Amendment No. 1 will increase the FY 2022 Department of  
16 Health and Human Services Tribal Opioid Response Program Budget by  
17 \$309,521.00, from \$700,000.00 to \$1,009,521.00; and

18 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have  
19 reviewed the FY 2022 Department of Health and Human Services Tribal Opioid  
20 Response Program Budget Amendment No. 1 and recommend its approval.

21 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
22 FY 2022 Department of Health and Human Services Tribal Opioid Response  
23 Program Budget Amendment No. 1 effective September 30, 2021, in the amount of  
24 \$1,009,521.00 which shall be funded by the Nation's general fund pending  
25 reimbursement from the grantor U.S. Department of Health and Human Service,  
26 Substance Abuse and Mental Health Services Administration.

27 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
28 Nation chairperson or any designated official is authorized to administer and  
29 expend the FY 2022 Department of Health and Human Services Tribal Opioid  
30 Response Program Budget as amended, provided that any amendments or  
31 modifications shall be submitted for prior approval by the Tohono O'odham  
32 Legislative Council.
