12	WHEREAS,	the FY 2022 Sells District Administration and Communities Budgets in the
13		amount of \$3,888,132.28 was authorized by Sells District Council Resolution SD-
14		88-21 and approved by Legislative Council Resolution No. 21-371; and
15	WHEREAS,	by Sells District Council Resolution No. SD-59-22, the Sells District has authorized
16		and submitted for review and approval its FY 2022 Sells District Administration
17		Budget Amendment No. 2, which is incorporated by this reference and which will
18		adjust operational and/or personnel line items; and
19	WHEREAS,	the FY 2022 Sells District Administration Budget Amendment No. 2 will not change
20		the FY 2022 Sells District Administration Budget amount of \$3,888,132.28; and
21	WHEREAS,	the Budget and Finance Committee has reviewed the FY 2022 Sells District
22		Administration Budget Amendment No. 2 and recommends its approval.
23	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
24		FY 2022 Sells District Administration Budget Amendment No. 2, which will not
25		change the FY 2022 Sells District Administration Budget amount of \$3,888,132.28.
