

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2022-FY 2023 Department of Public Safety Fire Department
Capital Project Budget Amendment No. 1)

RESOLUTION NO. 22-245

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinances (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2021 Department of Public Safety Fire Department Capital Project Budget
8 was approved by Resolution No. 20-351 in the amount of \$4,699,533.40; and

9 **WHEREAS,** Resolution No. 21-425 extended the FY 2021 Department of Public Safety Fire
10 Department Capital Project Budget until September 30, 2022 into FY 2022 and
11 authorized the Accounting Department "to post the unexpended balances of the
12 budget as of September 30, 2021 as a carry forward in FY 2022 beginning October
13 1, 2021"; and

14 **WHEREAS,** the Department of Public Safety has prepared and submitted for review and
15 approval its FY 2022-FY 2023 Fire Department Capital Project Budget Amendment
16 No. 1, which is incorporated by this reference and which will add new line item
17 7006 Supplies - Operating Equipment; and

18 **WHEREAS,** the FY 2022-FY 2023 Department of Public Safety Fire Department Capital Project
19 Budget Amendment No. 1 will not change the budget amount of \$3,810,915.07, but
20 it will extend the budget authority to September 30, 2023 into FY 2023; and

21 **WHEREAS,** the Domestic Affairs and Budget and Finance Committees have reviewed the FY
22 2022-FY 2023 Department of Public Safety Fire Department Capital Project
23 Budget Amendment No. 1 and recommend its approval.

24 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
25 FY 2022-FY 2023 Department of Public Safety Fire Department Capital Project
26 Budget Amendment No. 1 effective October 1, 2021, which will not change the
27 budget amount of \$3,810,915.07, but which will extend the budget authority to
28 September 30, 2023.

29 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
30 Nation chairperson or any designated official is authorized to administer and
31 expend the FY 2022-FY 2023 Department of Public Safety Fire Department Capital
32 Project Budget Amendment No. 1 as amended provided that any amendments or

modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH day of JULY, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by, Article VI, Section 1(d) (2) and (3) Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
