

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 22 Dentons US LLP Attorney Contract Amendment No. 1  
(Regarding Wo'oshan Land Issues)**

**RESOLUTION NO. 22-246**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized to retain legal counsel and  
2 "manage any funds within the exclusive control of the Tohono O'odham  
3 Nation...and to appropriate these funds for the benefit of the nation and its  
4 members" provided that "[a]ll expenditures of these funds shall be pursuant to  
5 appropriations or budgets" authorized by resolution or ordinance (Constitution  
6 of the Tohono O'odham Nation, Article VI, Section 2(a)); and

7 **WHEREAS,** the FY 2022 Dentons US LLP Attorney Contract regarding Wo'oshan land issues in  
8 the amount of \$30,000.00 was approved by Resolution No. 21-394; and

9 **WHEREAS,** the Office of Attorney General has prepared and submitted for review and  
10 approval its FY 2022 Dentons US LLP Attorney Contract Amendment No. 1, which  
11 is incorporated by this reference and which adds \$40,000.00 additional funds to  
12 the contract; and

13 **WHEREAS,** the FY 2022 Dentons US LLP Attorney Contract Amendment No. 1 will change the  
14 total contract amount for FY 2022 to \$70,000.00; and

15 **WHEREAS,** the Domestic Affairs Committee and Budget and Finance Committee have  
16 reviewed the FY 2022 Dentons US LLP Attorney Contract Amendment No. 1 and  
17 recommends it approval.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
19 Dentons US LLP Contract Amendment No. 1 which changes the total FY 2022  
20 contract amount to \$70,000.00.

21 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
22 Nation chairperson or any designated official is authorized to administer and  
23 expend the FY 2022 Dentons US LLP Attorney Contract funds, as amended,  
24 provided that any amendments or modifications shall be submitted for prior  
25 approval by the Tohono O'odham Legislative Council.

26 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup>  
27 day of JULY, 2022 at a meeting at which a quorum was present with a vote of 2,661.5 FOR; -0-  
28 AGAINST; -0- NOT VOTING; and 556.5 [06] ABSENT, pursuant to the powers vested in the Council  
29 by, Article VI, Section 1(f) and Section 2(a) Constitution of the Tohono O'odham Nation, adopted  
30 by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy  
31 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the  
32 Act of June 18, 1934 (48 Stat.984).
