

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Nominating Representative Victoria Hobbs to Serve as a Member on the U.S. Department of
Housing and Urban Development-Tribal Intergovernmental Advisory Committee and
Representative Edward Manuel as an Alternate Member)

RESOLUTION NO. 22-249

1 **WHEREAS,** the Constitution of the Tohono O'odham Nation vests the Legislative Council with
2 the authority to "promote, protect and provide for public health, peace, morals,
3 education and general welfare of the Tohono O'odham Nation and its members"
4 and to "provide for, appoint, or provide for the appointment of, and prescribe the
5 duties and powers of committees, boards, officers and agents" (Constitution,
6 Article VI, Section 1(f) and Section 1(c)(2)); and

7 **WHEREAS,** the U.S. Department of Housing and Urban Development ("HUD") has solicited
8 nominations for the newly created Tribal Intergovernmental Advisory
9 Committee ("TIAC"); and

10 **WHEREAS,** the TIAC was created to further communications between the HUD and federally
11 recognized tribes on HUD programs, make recommendations to HUD regarding
12 current program regulations, provide advice in the development of HUD's
13 American Indian and Alaska Native housing priorities, and encourage peer
14 learning and capacity building among tribes and non-tribal entities; and

15 **WHEREAS,** the Nation desires to build a nation-to-nation relationship with the United States
16 of America, grow a partnership with HUD, and learn from other tribal nations to
17 better address housing needs in Indian Country; and

18 **WHEREAS,** it is in the best interests of the Nation to nominate Representative Victoria Hobbs,
19 the current Legislative Council Housing Committee chairperson, as a member of
20 TIAC and Representative Edward Manuel, the current Legislative Council
21 Housing Committee vice-chairperson, as an alternate member; and

22 **WHEREAS,** the Housing Committee recommends nominating Representative Victoria Hobbs
23 to serve as a member on the U.S. Department of Housing and Urban Development
24 Tribal Intergovernmental Advisory Committee and Representative Edward
25 Manuel as an alternate member.

26 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council nominates
27 Representative Victoria Hobbs to serve as a member on the U.S. Department of
28 Housing and Urban Development-Tribal Intergovernmental Advisory Committee
29 and Representative Edward Manuel as an alternate member; provided that
30 appointments shall immediately expire if Representative Victoria Hobbs or



Representative Edward Manuel no longer serve on the Legislative Council Housing Committee for any reason.




