

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending Enrollment Resolution Nos. 27-84, 138-87, 98-123, 04-212, 04-350, 05-054, 05-711, 06-787, 07-075, and 21-088 to Correct Names and/or Date of Birth of Enrolled Members)**

**RESOLUTION NO. 22-256**

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to enact laws  
2 and ordinances governing the enrollment and adoption of members  
3 (Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and  
4 Article VI, Section 1(h)); and

5 **WHEREAS,** pursuant to Articles VI and VII of the Nation's Enrollment Ordinance, the  
6 Enrollment Committee shall review membership applications and make a  
7 written recommendation to the Tohono O'odham Legislative Council to approve  
8 or reject the application (14 Tohono O'odham Code Chapter 1 - Enrollment  
9 Ordinance); and

10 **WHEREAS,** pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono  
11 O'odham Legislative Council shall determine eligibility for membership or  
12 adoption; and

13 **WHEREAS,** the Enrollment Program has determined that a number of resolutions approving  
14 membership and adoption applications misspelled or incorrectly listed the  
15 names and/or date of birth of members; and

16 **WHEREAS,** the Enrollment Program recommends that Resolution Nos. 27-84, 138-87, 98-123,  
17 04-212, 04-350, 05-054, 05-711, 06-787, 07-075, and 21-088 be amended to reflect  
18 the correct names and/or date of birth of members identified in the August 2022  
19 Corrected Enrollment Resolution Summary, which is incorporated by this  
20 reference.

21 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that Resolution  
22 Nos. 27-84, 138-87, 98-123, 04-212, 04-350, 05-054, 05-711, 06-787, 07-075, and 21-  
23 088 are amended upon the effective date of those resolutions to reflect the correct  
24 names and/or date of birth of members identified in the August 2022 Corrected  
25 Enrollment Resolution Summary.

26 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01<sup>ST</sup>  
27 day of AUGUST, 2022 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-  
28 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by,  
29 Article II, Sections 1 and 2 and Article VI, Section 1(h) Constitution of the Tohono O'odham  
30 Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting  
31 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
32 16 of the Act of June 18, 1934 (48 Stat.984).
